What are cookies and similar technologies?

A cookie (or such similar technology) is a text file containing small amounts of information that websites you visit ask your browser to store on your device (such as your computer or mobile device) to remember information about you, your preferences, or your device information when you return to it. For example, such technologies can be used by websites to identify visitors, enable the website to function efficiently, personalize content, and permit online behavioral targeted advertising. “Similar technologies” include local objects (sometimes called flash cookies), web beacons, pixels, browser fingerprinting technologies, or any other technology that stores or accesses information on your device. This information does not usually allow us to identify you, but it can offer you a better user experience when visiting websites.

What cookies do we use?

The types of cookies we use are listed below and fall under two categories, strictly necessary and optional. This means that what cookies we place when you visit our website will depend on your choice.

We use both first and third-party cookies. Any cookies that are set by the website that you are visiting are called first-party cookies, whilst any cookies which are from a domain different than the domain of the website you are visiting are called third-party cookies. These cookies are placed by someone other than us. An example of this is when we embed a link to a third-party website, such as fda.gov.

Some cookies are deleted once you close your internet browser (“session cookies”) “Persistent cookies” on the other hand stay on your browser for a longer period and are not deleted once you close it, so for example a website you revisit remembers your language of choice. The tables below contain details on the lifespan of the cookies we use.

Functional and Required Cookies

Required cookies are cookies that are necessary for the operation of our website and use of its features, and therefore cannot be switched off in our systems. The information collected relates to the operation of our website (*e.g.*, website scripting language and security tokens) and enables us to provide you with the service you have requested. These cookies do not store any personal data. These cookies are used solely to enable the transmission of a communication over an electronic communications network. Functional cookies are optional and are used These cookies are optional and are used to remember the choices you have made, for example the country you visit our website from, your language and any changes you have made to text size and other parts of the web pages that you can customize to improve your user experience. If you do not allow these cookies, then some or all of these services may not function properly on our website. The use of these cookies for the purposes described above is based on our legitimate interest to ensure the proper technical functioning of and access to our website and to provide you with the service(s) you have expressly requested. Below is a list of functional and required cookies used by our website.

Cookie Name	Duration	Purpose
__cfllb	24 hours	Cloudflare load balancer, it helps user experience.
__cf_bm	30 minutes of continuous inactivity	The cookie contains information related to the calculation of Cloudflare's proprietary bot score and when Anomaly Detection is enabled on Bot Management, a session identifier. The information in the cookie (other than time-related information) is encrypted and can only be decrypted by Cloudflare.
cf_ob_info and cf_use_ob	30 seconds	Helps the Cloudflare platform decide when to use true online cache technology.
cf_clearance	5 minutes of continuous inactivity	Cloudflare security layer; It is used to no longer issue a captcha or jschallenge challenge if present. It is required to reach origin server.
cf-cc-XXX; cf-chl-cc-XXX; cf-chl-seq-XXX; cf-chl-prog	5 minutes	These cookies are used by Cloudflare for the execution of Javascript or Captcha challenges.
cf-chl-XXXX	30 seconds	This cookie is used to check whether the Cloudflare Edge server supports cookies.
cf-chl-rc-i; cf-chl-rc-ni	24 hours	These cookies are for internal use which allows Cloudflare to identify production issues on clients.

Analytics and Performance cookies

These cookies are optional and are used to collect information on how visitors use our website, for example which pages they visit most often, whether they receive any error messages and how they arrived at our website. Information collected by these cookies is used only to improve the use of our website by our visitors. These cookies are sometimes placed by third-party providers of web traffic and analysis services. All information these cookies collect is aggregated and

therefore anonymous. If you do not allow these cookies we will not know when people have visited our site and will not be able to monitor its performance.
